Now is the time to introduce and pass the Medical Freedom Amendment. There is an urgency to adopt the Amendment never more clearly presented before us than today.

**Proposed 28th Amendment to
the United States Constitution**
The Medical Freedom Amendment

Statement of the Amendment

"All people have the Right to secure their Health in the manner they choose. Congress, the President, State Legislatures and Executives, Governmental Agencies or Departments shall make no law, rule, regulation, countermeasure, executive, emergency order, or enter into any treaty or international agreement that impedes the Individual's rights to informed consent nor right to medical choice nor freedom of medical choice. The treaty provision of Article VI of this Constitution shall not apply in any way to this amendment.

Nor shall the President, Congress, State Legislatures and Executives, Governmental Agencies or Departments make any law, rule, regulation, countermeasure, executive, emergency order, or enter into any treaty or international agreement that impedes the Individual's right to medical privacy and freedom without individual and specific judicial warrant supported by Oath and affirmation of necessary cause to protect Society from Harm describing the Individual's condition and danger it presents."

Why should you support this Amendment?

Have you recognized what has happened to medical freedom and the unrelenting attacks and abuses it has received? Are you aware of the unanswered issues and problems forced medical treatment has unleashed on your constituents? Have your constituents informed you of unnecessary deaths and harm? This issue and this questionnaire need your response and acknowledgement for your constituency. Critical information and knowledge are routinely censored, and your constituency are victims of that censorship leading them into a state of fear and distrust of the government.

The National government has patents and financial commitments with international corporations, foreign countries, and the World Health Organization. Medical rights are now being nullified by pre-planned symposiums of possible future illnesses aided by artificial intelligence, wireless surveillance, profit driven science, and error driven data sequences. When exposed by those who present different scientific and medical experience, the government silences, censors and ruins their livelihoods meanwhile acting oblivious of the great harm inflicted by these draconian policies.

As a result, we are witnessing medical censorship, medical discrimination, and medical abuse of such great magnitude we have never experienced before. We witness little accountability or responsibility on the part of government to respond appropriately. We are aware, however, of fourteen States that are acting in the direction of this Amendment. This is a national Amendment and reflects our American values of individual rights, sovereignty, and freedoms. We need your action to protect your constituency and all of us from the abusers, oppressors, and censors by endorsing the Medical Freedom Amendment and bringing transparency and investigation to this intolerable situation.

We call upon your judgement and integrity to endorse this Amendment and to end this cycle now. The United States Constitution must now protect Individual rights of informed consent, freedom of medical choice, medical freedom, and medical privacy by the enactment of the [Medical Freedom Amendment](#).
